

CEDAR BREEZE KENNELS

Boarding & Daycare Agreement and Liability Waiver

This Agreement applies to all boarding and daycare services provided by Cedar Breeze Kennels ("CBK"), located at 2114 Driving Range Road.

Please initial each section to acknowledge understanding and agreement:

Ownership & Authority

_____ I represent that I am the legal owner of the dog(s) listed below, or I am authorized by the owner to enter into this Agreement on their behalf. I am at least eighteen (18) years of age.

Health & Vaccination Requirements

_____ I certify that my dog(s) is/are in good health and free from contagious illness. My dog(s) is/are current on required vaccinations including Rabies, Canine Distemper, and Bordetella (Kennel Cough).

_____ I certify that my dog(s) has been free of fleas, ticks, lice, or other parasites within the past thirty (30) days.

_____ I understand that vaccines are not guaranteed to prevent illness and that, despite CBK's safety measures, my dog(s) may be exposed to contagious conditions. I accept this risk and agree that I am solely responsible for any resulting veterinary care or medical expenses.

Parasites or Illness Discovered During Boarding

_____ If fleas, ticks, parasites, or contagious illness are discovered during boarding, I authorize CBK to provide treatment at my expense and/or isolate my dog(s) for the safety of other animals.

Behavior & Temperament Disclosure

_____ I certify that my dog(s) has not harmed, bitten, or shown aggressive or threatening behavior toward any person or other animal.

_____ I further certify that I have fully disclosed any history of aggression, biting, resource guarding, severe anxiety, destructive behavior, or escape attempts.

_____ I specifically acknowledge that I have disclosed whether my dog(s) has ever:

- Jumped or climbed fencing
- Dug under fencing
- Forced open gates
- Broken or damaged crates or kennel panels
- Chewed through enclosures
- Escaped from prior boarding facilities or homes

_____ I understand that failure to disclose prior escape or destructive behavior constitutes material misrepresentation.

_____ In the event my dog(s) escapes, damages fencing or enclosures, causes injury, or creates liability due to undisclosed behavior, I agree to assume full responsibility for all resulting damages, veterinary costs, property damage, third-party claims, legal expenses, and attorney fees. I agree to indemnify, defend, and hold harmless Cedar Breeze Kennels, its owners, employees, and representatives from any such claims.

_____ I understand that CBK reserves the right to immediately terminate boarding services without refund if undisclosed behavioral risks are discovered.

Veterinary Care Authorization

_____ If my dog(s) becomes ill or injured while in CBK's care and I cannot be reached, I authorize CBK to seek veterinary treatment deemed necessary.

I authorize veterinary expenses up to \$_____ without additional consent.

I understand and agree that I am solely responsible for all veterinary expenses incurred.

Assumption of Risk

_____ I understand that dog boarding and daycare involve inherent risks including, but not limited to:

- Dog fights, bites, scratches, or sprains
- Stress-related illness
- Transmission of disease
- Escape attempts
- Fence climbing or digging behavior
- Destruction of crates or enclosures
- Unforeseeable accidents

I voluntarily assume all such risks on behalf of myself and my dog(s).

Supervision & Facility Policies

_____ I understand that although dogs are supervised, minor injuries may occur during play.

_____ I understand that CBK reserves the right to remove my dog(s) from group play and place them in a separate area if they display unsafe or unwanted behavior.

_____ My dog(s) must wear a properly fitted collar or safety collar during their stay.

Release of Liability

_____ I release and hold harmless Cedar Breeze Kennels, its owners, employees, and representatives from any and all liability for injury, illness, loss, damage, or death of my dog(s) occurring during boarding or daycare services, except in cases of gross negligence or willful misconduct.

This release applies to incidents occurring on or off the premises in connection with services provided.

Payment, Pickup & Abandonment

_____ I understand that boarding is charged on a 24-hour cycle (e.g., drop-off at 8:00 AM, pick-up at 8:00 AM). Pickups beyond the 24-hour period may result in additional daycare charges.

_____ If I am unable to pick up my dog(s) at the agreed time, I authorize CBK to continue boarding services at my expense.

_____ Any dog not picked up within five (5) days of the scheduled pickup date, without communication or payment, may be deemed abandoned. CBK reserves the right to surrender the dog(s) to animal control or a rescue organization. I remain financially responsible for all accrued charges.

Property Damage & Indemnification

_____ I agree to be financially responsible for any personal injury or property damage caused by my dog(s), including damage to fencing, kennel panels, crates, buildings, or equipment.

_____ If any claim is made against Cedar Breeze Kennels, its owners, employees, or representatives due to the actions of my dog(s), I agree to indemnify, defend, and hold them harmless from such claims.

Force Majeure

_____ Cedar Breeze Kennels shall not be held liable for injury, loss, or damage caused by events beyond its reasonable control, including but not limited to fire, flood, tornado, severe weather, theft, power outage, or other acts of God.

Photo & Media Release (Optional)

_____ I grant Cedar Breeze Kennels permission to photograph or video my dog(s) for promotional or marketing purposes without compensation.

Entire Agreement & Truthfulness

_____ I certify that all information provided is complete and truthful. I understand that any false statements may result in immediate termination of services without refund and assumption of full liability.
